The Performance level of cover is suitable for cyclists who want cover for their bikes while riding or taking part in sportives, while traveling for periods of up to 30 days within Europe, and / or for bicycles worth £3000 or less. This cover excludes claims which occur while racing, while traveling outside of Europe, for single trips exceeding 30 days, and for bikes worth more than £3000. You must make your own decision as to whether this policy is suitable for your specific needs.

**An annualised premium includes any adjustments you may have made during the year. This represents an annual equivalent cost of £100. The total amount paid for last year's Insurance in the example was £350. The total annualised premium for the example is £400.
